**On 21 August 2016 (“the first date of the sale”)**

**(I) Abstract**

The sale of specified residential properties (“**Specified Residential Properties**”) will be divided into the following 2 sessions (namely Session A and Session B). Any person interested in purchasing any of the specified residential properties (the “**registrant**”) may participate in both Session A and Session B, or only in Session A or Session B.

<i>Session</i>	<i>Specified Residential Properties that will be offered to be sold in that Session</i>	<i>Rules for selecting Specified Residential Properties</i>
A	All Specified Residential Properties.	In Session A, registrant must purchase at least <b>two (2)</b> but not more than <b>six (6)</b> Specified Residential Properties, provided that at least <b>one (1)</b> Specified Residential Property the saleable area thereof is or above 429 sq. ft.
B	After the completion of Session A, all remaining Specified Residential Properties which are still available for sale.	In Session B, registrant may purchase not more than <b>two (2)</b> Specified Residential Properties.

**(II) Procedures for Session A**

1. Balloting will be used to determine the order of priority. Eligible persons interested in purchasing any of the Specified Residential Properties that will be offered to be sold in Session A (“**Bulk Purchase Registrants**”) must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II) and (IV) of this Sales Arrangements.

2. A Bulk Purchase Registrant must submit the following:-

- (a) only one Bulk Purchase Registration of Intent duly completed and signed by the Bulk Purchase Registrant;
- (b) Bulk Purchase Registration of Intent shall be accompanied with cashier orders. The number of cashier orders shall be equal to the number of Specified Residential Properties which the Bulk Purchase Registrant intends to purchase as indicated in the Bulk Purchase Registration of Intent, but such number of residential properties in any event shall not exceed 6. Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE & LO”; and
- (c) a copy of the Bulk Purchase Registrant’s H.K.I.D. Card(s)/Passport(s) or (if applicable) a copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. to the WTC Venue after relevant price lists of the Specified Residential Properties are made available till 4:00 p.m. on 19 August 2016 during office hours (i.e. from 12:00 p.m. to 8:00 p.m. everyday except that on 19 August 2016 the office hours shall be from 12:00 p.m. to 4:00 p.m.). The closing time for submission of Bulk Purchase Registration of Intent will be 4:00 p.m. on 19 August 2016. Late submission or submission outside the office hours will not be accepted.

3. Balloting of Session A will take place in batches:

(a) First round balloting (for dividing all Bulk Purchase Registrants into group(s))

(i) The first round balloting will take place at or after 12:00 noon on 20 August 2016 at the WTC Venue for the purposes of dividing the Bulk Purchase Registrants into group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the WTC Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the WTC Venue. Bulk Purchase Registrants will not be notified separately of such changes.

(ii) After the first round balloting, the Bulk Purchase Registrants will be divided into one or more group(s)

and the registrants in each group will be eligible to participate in the second round balloting.

(b) Second round balloting (for determining the order of priority of Bulk Purchase Registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting of the group(s) of Bulk Purchase Registrants will take place on the first date of sale in batches at the IFC Venue at such time(s) as posted by the Vendor pursuant to sub-paragraph (a)(iii) above. - (ii) For the purpose of verification of identity, Bulk Purchase Registrants (if the Bulk Purchase Registrant is a corporate, then any one of its directors) must bring along the original receipt of the Bulk Purchase Registration of Intent, his/her original H.K.I.D. Card(s)/Passport(s) or (if applicable) a copy of Business Registration Certificate and the original H.K.I.D. Card(s)/Passport(s) of the director(s) and **personally** attend the **IFC Podium** according to “check-in timeslot for each group” posted by the Vendor. Bulk Purchase Registrants who arrive at the IFC Podium beyond “check-in time slot for each group” shall not be eligible to participate in the second round balloting.
- (iii) The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the second round balloting, make use of Shop 401 and 402, 4/F, Exchange Square Podium, Central, Hong Kong (“**Additional Venues**”) to accommodate some of the Bulk Purchase Registrants by making announcement at the IFC Venue, the IFC Podium, and the Additional Venues and direct the registrants to the Additional Venues.
- (iv) A Bulk Purchase Registrant who leaves the IFC Venue and/or the Additional Venues (if applicable) while his/her/their/its group is in sessions for selecting and purchasing specified residential properties may be disqualified for participating in selecting and purchasing the specified residential properties and his/her/their/its order of priority shall lapse immediately.
- (v) For the purpose of the balloting, every valid Bulk Purchase Registration of Intent shall be allotted one lot. The results of the balloting, including “registration number” and “ballot result sequence” will be announced and/or posted by the Vendor at the IFC Venue and the Additional Venues (if applicable). Bulk Purchase Registrants will not be separately notified of the ballot results.

- 4. (a) Immediately after the second round balloting, Bulk Purchase Registrants shall **personally** select the Specified Residential Properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time.
- (b) The Bulk Purchase Registrants shall **in compliance with the rules set out in the Abstract in Section (I) above** select and purchase Specified Residential Properties, otherwise his/her/its/their order of priority shall lapse automatically and he/she/it/they will no longer be eligible to participate in this Session A.
- (c) If the number of Specified Residential Properties the Bulk Purchase Registrant purchases exceeds the number of cashier orders submitted with the Bulk Purchase Registration of Intent, the Bulk Purchase Registrant shall submit on spot to the Vendor one cashier order for each extra Specified Residential Property. Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE & LO”.

(III) Procedures for Session B

- 7. Balloting will be used to determine the order of priority. Eligible persons interested in purchasing any of the Specified Residential Properties that will be offered to be sold in Session B must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (III) and (IV) of this Sales Arrangements.
- 8. The Vendor may postpone the commencement of Session B pending completion of Session A. Registrants will not be separately notified of such change.
- 9. A registrant must submit the following:-
  - (a) only one Registration of Intent duly completed and signed by the registrant;
  - (b) Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of Specified Residential Property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed 2. Each cashier order shall be in the sum of HK\$100,000 and made payable to "WOO KWAN LEE & LO"; and
  - (c) a copy of the registrant's H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to the WTC Venue after relevant price lists of the Specified Residential Properties are made available till 4:00 p.m. on 19 August 2016 during office hours (i.e. from 12:00 p.m. to 8:00 p.m. everyday except that on 19 August 2016 the office hours shall be from 12:00 p.m. to 4:00 p.m.). - 10. Balloting of Session B will take place in batches:
  - (a) First round balloting (for dividing all registrants into group(s))
    - (i) The first round balloting will take place at or after 12:00 noon on 20 August 2016 at the WTC Venue for the purposes of dividing the registrants into group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the WTC Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the WTC Venue. registrants will not be notified separately of such changes.

- (ii) After the first round balloting, the registrants will be divided into one or more group(s) and the registrants in each group will be eligible to participate in the second round balloting.
- (iii) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at P115-117 on P1/F of wtc more, 280 Gloucester Road, Causeway Bay, Hong Kong, after completion of the first round balloting. Registrants will not be separately notified of the ballot results.

(b) Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting of the group(s) of registrants will take place on the first date of sale in batches at the IFC Venue at such time(s) as posted by the Vendor pursuant to sub-paragraph (a)(iii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the IFC Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the IFC Venue, the IFC Podium and the Additional Venues (see sub-paragraph (b)(iii) below) (if applicable). Registrants will not be notified separately of such changes.
- (ii) For the purpose of verification of identity, registrants (if the registrant is a corporate, then any one of its directors) must bring along the original receipt of the Registration of Intent, his/her original H.K.I.D. Card(s)/Passport(s) or (if applicable) a copy of Business Registration Certificate and the original H.K.I.D. Card(s)/Passport(s) of the director(s) and **personally** attend the **IFC Podium** according to “check-in timeslot for each group” posted by the Vendor. Registrants who arrive at the IFC Podium beyond “check-in time slot for each group” shall not be eligible to participate in the second round balloting.

- (c) If the number of Specified Residential Properties the Registrant purchases exceeds the number of cashier orders submitted with the Registration of Intent, the Registrant shall submit on spot to the Vendor one cashier order for each extra Specified Residential Property. Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE &
- (d) If the registrant has successfully selected a Specified Residential Property(ies) in compliance with the rules set out in the Abstract in Section (I), the registrant shall **personally** enter into one or two Preliminary Agreement(s) for Sale and Purchase of the selected Specified Residential Property(ies).
- (e) Prior to the signing of the Preliminary Agreement(s) for Sale and Purchase, the registrant may notify the Vendor on spot to add name(s) of individual(s), provided that the additional individual(s) must be the **direct family**

**member(s)** (i.e. spouse, parents and children) of **ALL** the individual(s) comprised in the registrant and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final. All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant's request to add any the name(s) of any individual(s).

**(IV) General Procedures**

12. The following apply to registration:-
- (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Bulk Purchase Registration of Intent / Registration of Intent. Duplicated registration in a Session will not be accepted.
  - (b) The Bulk Purchase Registration of Intent / Registration of Intent is personal to the registrant and shall not be transferable.
  - (c) The order of submission of the Bulk Purchase Registration of Intent / Registration of Intent will not have any impact on the order of priority for selecting the Specified Residential Properties.
  - (d) In case of dispute, the Vendor reserves its right to determine whether a Bulk Purchase Registration of Intent / Registration of Intent is valid and should be included in balloting.
  - (e) (If the registrant comprises corporation) if after the submission of the Bulk Purchase Registration of Intent / Registration of Intent, there is any change in the directorship of the corporation, the Bulk Purchase Registration of Intent / Registration of Intent shall become invalid immediately and the registrant shall not be eligible to participate in Session A and Session B.
13. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the Specified Residential Property(ies).
14. The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.
15. If a registrant has not purchased any Specified Residential Property, his/her/its/their unused cashier order(s) will be available for collection by the registrant (or his/her/its/their authorized person) at the WTC Venue from 23 August 2016 to 28 August 2016 during office hours (i.e. from 11:00 a.m. to 7:00 p.m. everyday). In case of any dispute, the Vendor reserves its absolute right to allocate any Specified Residential Properties to any person interested in purchasing by any method (including balloting).
17. The Vendor reserves the right to close the IFC Podium, IFC Venue and the Additional Venues (if applicable) at any time if all the Specified Residential Properties have been sold out.
18. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 8:00 p.m. on the date on which Bulk Purchase Registration of Intent / Registration of Intent may be submitted and/or at any time between the hours of 7:00 a.m. and 11:00 p.m. on the first date of the sale, then, for the safety of the registrants and the maintenance of order at the IFC Podium, IFC Venue, WTC Venue and/or the Additional Venues (if applicable), the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Bulk Purchase Registration of Intent / Registration of Intent and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the IFC Podium, IFC Venue, WTC Venue and/or the Additional Venues (if applicable). Registrants will not be notified separately of the arrangement.

**On 22 August 2016 and thereafter:**

19. Subject to the completion of the selecting and purchasing of the Specified Residential Properties by eligible persons in

accordance with the above procedures, the remaining Specified Residential Properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining Specified Residential Properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining Specified Residential Properties to any person interested in purchasing by any method (including balloting).

20. The Vendor reserves the right to close the IFC Venue / WTC Venue (as the case may be) at any time if all the Specified Residential Properties have been sold out, provided that the WTC Venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 15 above.
21. If the Vendor postpones the first date of the sale to such other date pursuant to this Sales Arrangements, the subsequent dates of sale will be postponed accordingly.
22.
