Persons interested in purchasing any of the specified residential properties (the "Registrant") must follow the procedures below:-

- 1. A Registrant must purchase at least **one** (1) but not more than **six** (6) specified residential property, provided that not more than **one** (1) specified residential property is a studio unit.
- 2. A Registrant must submit the following:-
  - (a) only one Registration of Intent duly completed and signed by the Registrant;
  - (b) A Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the Registrant intends to purchase as indicated in the Registration of Intent. Each cashier order shall be in the sum of HK\$100,000 and made payable to "WOO KWAN LEE & LO"; and
  - (c) a copy of the Registrant's H.K.I.D. Card(s)/Passport(s) or (if applicable) copies of the Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to the WTC Venue after relevant price lists of the specified residential properties are made available till 3:00 p.m. on 21 October 2016 during office hours (i.e. from 11:00 a.m. to 7:00 p.m. everyday except that on 21 October 2016 the office hours shall be from 11:00 a.m. to 3:00 p.m.). The closing time for submission of Registrations of Intent will be 3:00 p.m. on 21 October 2016. Late submission or submission outside the office hours will not be accepted.

#### 3. Balloting:

- (a) On the first date of the sale, the Registrant who holds a valid Registration of Intent (if the Registrant comprises corporation, then all directors of that corporation) shall **personally** attend the WTC G/F Venue between 10:00 a.m. and 10:15 a.m.. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of G/F of **wtc more** and/or Room 2504-06, Room 3506 and Room 3604, World Trade Centre, 280 Gloucester Road, Causeway Bay, Hong Kong (collectively the "**Additional WTC Venues**") to accommodate some of the Registrants by making announcement at the WTC G/F Venue, WTC Venue and the Additional WTC Venues.
- (b) For the purpose of verification of identity, the Registrants must bring along the original receipt of the valid Registration of Intent and his/her/their original H.K.I.D. Card(s)/Passport(s) or (if applicable) copies of the Business Registration Certificate and the original H.K.I.D. Card(s)/Passport(s) of the director(s). Registrants who arrive at the WTC G/F Venue or (if directed by the Vendor) the Additional WTC Venues beyond 10:15 a.m. on the first day of the sale shall not be eligible to participate in the balloting.
- (c) (If the Registrant comprises corporation) if after the submission of Registration of Intent there is any change in the directorship of the corporation, the Registration of Intent shall become invalid immediately and the Registrant shall not be eligible to participate in the balloting.
- (d) After verification of the identity of the Registrants by the Vendor, the order of priority for selection of the specified residential properties will be determined by balloting which will take place at the WTC Venue. All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the Registrant's request to add any the name(s) of any individual(s).

#### **General Procedures**

- 5. The following apply to registration:-
  - (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent. Duplicated registration will not be accepted.
  - (b) The Registration of Intent is personal to the Registrant and shall not be transferable.
  - (c) The order of submission of the Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties.
  - (d) In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent is valid and should be included in balloting.
- 6. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
- 7. The Vendor shall not be responsible to the Registrants for any error or omission contained in the ballot results.
- 8. If a Registrant has not purchased any specified residential property, his/her/its/their unused cashier order(s) will be available for collection by the Registrant (or his/her/its/their authorized person) at the WTC Venue from 23 October 2016 to 30 October 2016 during office hours (i.e. from 11:00 a.m. to 7:00 p.m. everyday). - 9. After the completion of the balloting and selection of the specified residential properties by the eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).
- 10. The Vendor reserves the right to close the WTC G/F Venue, the WTC Venue and the Additional WTC Venues (if applicable) at any time if all the specified residential properties have been sold out.
- 11. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 8:00 p.m. on the date on which Registrations of Intent may be submitted and/or at any time between the hours of 7:00 a.m. and 11:00 p.m. on the first date of the sale, then, for the safety of the Registrants and the maintenance of order at the WTC G/F Venue, the WTC Venue and/or the Additional WTC Venues (if applicable), the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for

submission of Registrations of Intent and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the WTC G/F Venue, the WTC Venue and/or the Additional WTC Venues (if applicable). - 12. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting).
