

SUMMARY OF THE PRELIMINARY AGREEMENT FOR SALE AND PURCHASE

臨時買賣合約的摘要

1. A preliminary deposit of 5% is payable on the signing of the preliminary agreement for sale and purchase (the “preliminary agreement”);
 2. The preliminary deposit paid by the purchaser on the signing of the preliminary agreement will be held by a firm of solicitors acting for the owner, as stakeholders;
 3. If the purchaser fails to execute the agreement for sale and purchase within 5 working days after the date on which the purchaser enters into the preliminary agreement —
 - (i) the preliminary agreement is terminated;
 - (ii) the preliminary deposit is forfeited; and
 - (iii) the owner does not have any further claim against the purchaser for the failure.

 2. 買方在簽署該臨時合約時支付的臨時訂金，會由代表擁有人行事的律師事務所以保證金保存人的身分持有；
 3. 如買方沒有於訂立該臨時合約的日期之後5個工作日內簽立買賣合約 —
 - (i) 該臨時合約即告終止；
 - (ii) 有關的臨時訂金即予沒收；及
 - (iii) 擁有人不得就買方沒有簽立買賣合約而針對買方提出進一步申索。

SUMMARY OF DEED OF MUTUAL COVENANT

A Deed of Mutual Covenant and Management Agreement (“DMC”) is entered into in respect of the Development.

A. Common Parts of the Development

1. The common parts of the Development comprises “Development Common Areas and Facilities”, “Residential Common Areas and Facilities”, “Car Park Common Areas and Facilities”, “Residential and Commercial Common Areas and Facilities” and “Car Park and Commercial Common Areas and Facilities” as defined in the DMC.
2. “Development Common Areas and Facilities” means and includes (a)(i) such part of the external walls (including the Curtain Walls, external wall features and fins)(other than (1) those forming part of the Residential Accommodation and (2) those forming part of the Commercial Accommodation) of the Development which are shown and coloured Green on the elevation plans certified by the Authorized Person and annexed to the DMC; and (ii) Greenery Areas (Development Common Areas and Facilities) (which means those areas within and forming part of the Development Common Areas and Facilities and planted with trees, shrubs, grasses or other types of living plants as are shown for the purpose of identification only on the plans certified by the Authorized Person annexed to the DMC and coloured Green Stippled Black), Right of Way (Development Common)Area (which means such portion of the passage and open yard on the ground floor of the Development forming part of the Development Common Areas and Facilities as is for identification purpose only shown coloured Green Cross Hatched Black on the plans certified by the Authorized Person and annexed to the DMC), gondola, passages, entrances, walkways, stairways, staircases (including those staircases designated as means of escape under the Building Plans), landings, platforms, open spaces and decks, slopes and retaining walls (if any), boundary fence walls (if any), vertical green, lobbies, refuse storage and material recovery room, transformer rooms, cable chambers, main switch room, flushing water pump rooms, F.S. inlets, sprinkler control valve room, H.V. switchgear rooms,

emergency generator room, fuel tank room, sprinkler & F.S. pump room, security guard booth, water meter rooms, master water meter room, flushing water tank, switch room, F.S. water tanks, smoke vents, sprinkler water tank, steel platform, vent ducts, fireman’s lift lobby, covered channel, F.S. control room and such of the drains, channels, water mains, sewers, fresh and salt water storage tanks, fresh and salt water intakes and mains, communal television and radio aerial systems for reception of television and radio broadcast, telecommunications and broadcasting distribution networks, cable television system (if any), wires, cables and other facilities whether ducted or otherwise which are or at any time may be in under or over or passing through the Lot through which fresh or salt water, sewage, gas, telephone, electricity and other services are supplied to the Development, trees, shrubs and other plants and vegetation, lamp posts and other lighting facilities, fire prevention and fighting equipment and apparatus, security systems and apparatus, ventilation system and such other areas and any other mechanical systems, devices or facilities installed or provided in the Development intended for common use and benefit of the Development which are (in so far as the same are capable of being shown on plans) for the purposes of identification only shown coloured Green, Green Hatched Black, Green Stippled Black and Green Cross Hatched Black on the plans certified by the Authorized Person and annexed to the DMC; (b) and such other areas, systems, devices, services and facilities of and in the Lot and the Development as may at any time be designated as Development Common Areas and Facilities by the First Owner in accordance with the DMC; and (c) to the extent not specifically provided in paragraphs (a) and (b) above, such other parts of the Lot and the Development, (i) any parts of the Development covered by paragraph (a) of the definition of “**common parts**” set out in section 2 of the Building Management Ordinance (Cap.344) and/or (ii) any parts specified in Schedule 1 to the Building Management Ordinance (Cap.344) and included under paragraph (b) of the definition of “common parts” set out in section 2 of the Building Management

Ordinance (Cap.344); but EXCLUDING the Residential Common Areas and Facilities, the Car Park Common Areas and Facilities, the Residential and Commercial Common Areas and Facilities and the Car Park and Commercial Common Areas and Facilities and such areas within the Development the exclusive right and privilege to hold, use, occupy and enjoy which belongs to any particular Owner and such facilities within the Development serving only any particular Owner.

3. “Residential Common Areas and Facilities” means and includes (a)(i) such part of the external walls (including the Curtain Walls, external wall features and fins) of the Residential Accommodation of the Development (other than (1) those forming part of the Commercial Accommodation and (2) those forming part of the Development Common Areas and Facilities) which are for the purpose of identification only shown and coloured Red on the elevation plans certified by the Authorized Person and annexed to the DMC; (ii) Greenery Areas (Residential Common Areas and Facilities) (which means those areas within and forming part of the Residential Common Areas and Facilities and planted with trees, shrubs, grasses or other types of living plants as are shown for the purpose of identification only on the plans certified by the Authorized Person annexed to the DMC and coloured Red Stippled Black), Projecting Canopy (Residential Common Areas and Facilities) (which means the canopy on 1st Floor of the Development with parts protruding outside the Lot and forming part of the Residential Common Areas and Facilities as is for the purpose of identification only shown and coloured Red Cross Hatched Black on the plans certified by the Authorized Person and annexed to the DMC), Recreational Areas and Facilities, Visitors’ Parking Spaces, loading and unloading spaces serving the Residential Accommodation, and such of the passages, common corridors and lift lobbies (including the Wider Common Corridors and Lift Lobbies as are for the purpose of identification only shown and coloured Red Hatched Black on the plans certified by the Authorized Person and annexed hereto) and shuttle lift lobby, caretaker counter, refuge floors,

entrances, landings, entrance lobbies, air conditioning platforms, structural walls, stairways, staircases (including those staircases designated as means of escape under the Building Plans), store, lift pits, TBE room, irrigation and cleansing water tank room, filtration plant room, vent ducts, lift machine rooms, drencher transfer tank & pump rooms, drencher transfer water tanks, fire fighting and rescue stairways, potable water tanks, potable pump rooms, flushing water tanks, flushing water tank and pump room, sprinkler water tanks, sprinkler & F.S. pump room, F.S. water tanks, smoke vent, smoke outlet, lifts, steel platform, AHU room, planters, covered landscape areas, P.R.V. room, drencher pump rooms, water tanks, pump rooms, aerials, meters, lighting, drains, channels, sewers, salt and fresh water intakes and mains, wires, cables, air conditioning and ventilation system and other facilities whether ducted or otherwise through which fresh or salt water, sewage, gas, electricity and other services are supplied to the Residential Accommodation, planters, trees, shrubs and other plants and vegetation, pumps, tanks, sanitary fittings, electrical installations, fittings, equipment and apparatus, fire prevention and fighting equipment and apparatus, security systems and apparatus, ventilation system and such other areas and any other systems, devices or facilities which are at or provided or installed in the Development intended for the common use and benefit of the Owners and residents or tenants of the Residential Accommodation and their bona fide guests or visitors and such other areas within the Lot which are (in so far as the same are capable of being shown on plans) for the purposes of identification only shown coloured Red, Red Stippled Black, Red Cross Hatched Black and Red Hatched Black on the plans certified by the Authorized Person and annexed to the DMC; (b) and such other systems, devices and facilities within the Development as are designated by the First Owner for common use and benefit of the Residential Accommodation in accordance with the DMC but EXCLUDING the Development Common Areas and Facilities, the Car Park Common Areas and Facilities, the Residential and Commercial Common Areas and Facilities and the Car Park and Commercial Common Areas and Facilities and such areas within the Development in respect of which the exclusive

right and privilege to hold, use, occupy and enjoy the same belongs to any particular Owner and such facilities within the Development serving only any particular Owner.

4. “Car Park Common Areas and Facilities” means such part of the Car Parking Areas other than those specially designated as Car Parking Spaces including ramps, driveways, smoke extraction fan rooms, stairways and landings and all the water pipes, drains and wires and cables and lighting in respect of the Car Parking Areas, fire fighting installation and equipment, and any other facilities installed for the use and benefit of the Parking Spaces and includes such other areas, apparatus, devices, systems and facilities of and in the Development within the Car Parking Areas as are designated by the First Owner as Car Park Common Areas and Facilities but EXCLUDING the Development Common Areas and Facilities, the Residential Common Areas and Facilities, the Residential and Commercial Common Areas and Facilities, the Car Park and Commercial Common Areas and Facilities and such areas within the Development the exclusive right and privilege to hold, use, occupy and enjoy which belongs to any particular Owner and such facilities within the Development serving only any particular Owner. Such Car Park Common Areas and Facilities (if and where capable of being shown on plans) are for identification purpose only shown coloured Yellow on the plans certified by the Authorized Person and annexed to the DMC.

5. “Residential and Commercial Common Areas and Facilities” means and includes potable water tank, potable water pump room, lift lobbies, tel. ducts, gas meter room, TBE room and any other facilities installed for the use and benefit of the Owners of the Residential Units and the Owners of the Commercial Accommodation and includes such other areas, apparatus, devices, systems and facilities of and in the Development as are designated by the First Owner as Residential and Commercial Common Areas and Facilities

but EXCLUDING the Development Common Areas and Facilities, the Residential Common Areas and Facilities, the Car Park Common Areas and Facilities, the Car Park and Commercial Common Areas and Facilities and such areas within the Development the exclusive right and privilege to hold, use, occupy and enjoy which belongs to any particular Owner and such facilities within the Development serving only any particular Owner. Such Residential and Commercial Common Areas and Facilities (if and where capable of being shown on plans) are for identification purpose only shown coloured Orange on the plans certified by the Authorized Person and annexed to the DMC.

6. “Car Park and Commercial Common Areas and Facilities” means and includes staircase and fan rooms and any other facilities installed for the common use and benefit of the Owners of the Parking Spaces and the Owners of the Commercial Accommodation and includes such other areas, apparatus, devices, systems and facilities of and in the Development as are designated by the First Owner as Car Park and Commercial Common Areas and Facilities but EXCLUDING the Development Common Areas and Facilities, the Residential Common Areas and Facilities, the Residential and Commercial Common Areas and Facilities, the Car Park Common Areas and Facilities and such areas within the Development the exclusive right and privilege to hold, use, occupy and enjoy which belongs to any particular Owner and such facilities within the Development serving only any particular Owner. Such Car Park and Commercial Common Areas and Facilities (if and where capable of being shown on plans) are for identification purpose only shown coloured Brown on the plans certified by the Authorized Person and annexed to the DMC.

C. Term of years for which the manager of the Development is appointed

7. Kai Shing Management Services Limited is appointed under the DMC as the Manager of the Development for an initial period of not exceeding two years commencing from the date of the DMC and to be continued thereafter, subject to the provisions for termination contained in the DMC.

D. Basis on which the management expenses are shared among the owners of the residential properties in the Development

8. Each Owner of the Residential Units shall contribute towards the management expenses monthly in advance a contribution equal to 1/12th of the management expenses payable by that Owner for that year on the first day of each calendar month.

9. The Owners of Residential Units shall contribute towards the management expenses in the following manner:

(a) Each Owner shall pay for every Undivided Share allocated to any Unit (or any part thereof) of which he is the Owner a fraction of the total amount assessed under the first part of the annual adopted budget in which the numerator shall be one and the denominator is equal to the total number of Undivided Shares (excluding the Undivided Shares allocated to the Common Areas and Facilities) in the Development;

(b) Each Owner of the Residential Units in addition to the amount payable under sub-paragraph (a) above shall in respect of each Undivided Share allocated to a Residential Unit of which he is the Owner pay (i) a fraction of the total amount assessed under the first section of the second part of the annual adopted budget in which the numerator shall be one and the denominator is equal to the total number of Undivided Shares allocated to all the Residential Units; and (ii) a fraction of the total amount assessed under the third section of the second part of the annual adopted budget as referred to in Clause 14(b)(iii) of the DMC in which the numerator shall be one and the denominator is equal to the total number of Undivided Shares allocated to all the Residential Units and the

Commercial Accommodation;

(c) If a Sub-Deed is entered into in respect of any component part of the Development and a new section of the annual budget is established for that component part in accordance with Clause 14 Proviso (iii) of the DMC each Owner of that component part shall in addition contribute his due proportion of the budgeted management expenses for that section in the manner provided in the Sub-Deed;

(d) Where any expenditure for the management and maintenance of the Development and the Lot shall in the reasonable opinion of the Manager be specifically referable to or is being expended for a particular Unit or group of Units and no Owner of any other Unit shall receive any material benefit therefrom, the full amount shall be excluded from the annual budget and shall be paid by the Owner(s) of that particular Unit or group of Units on demand.

E. Basis on which the management fee deposit is fixed

10. The amount of management fee deposit is equivalent to three months' monthly management contribution payable in respect of each Undivided Share allocated to the Unit.

F. The area (if any) in the Development retained by the owner for that owner's own use

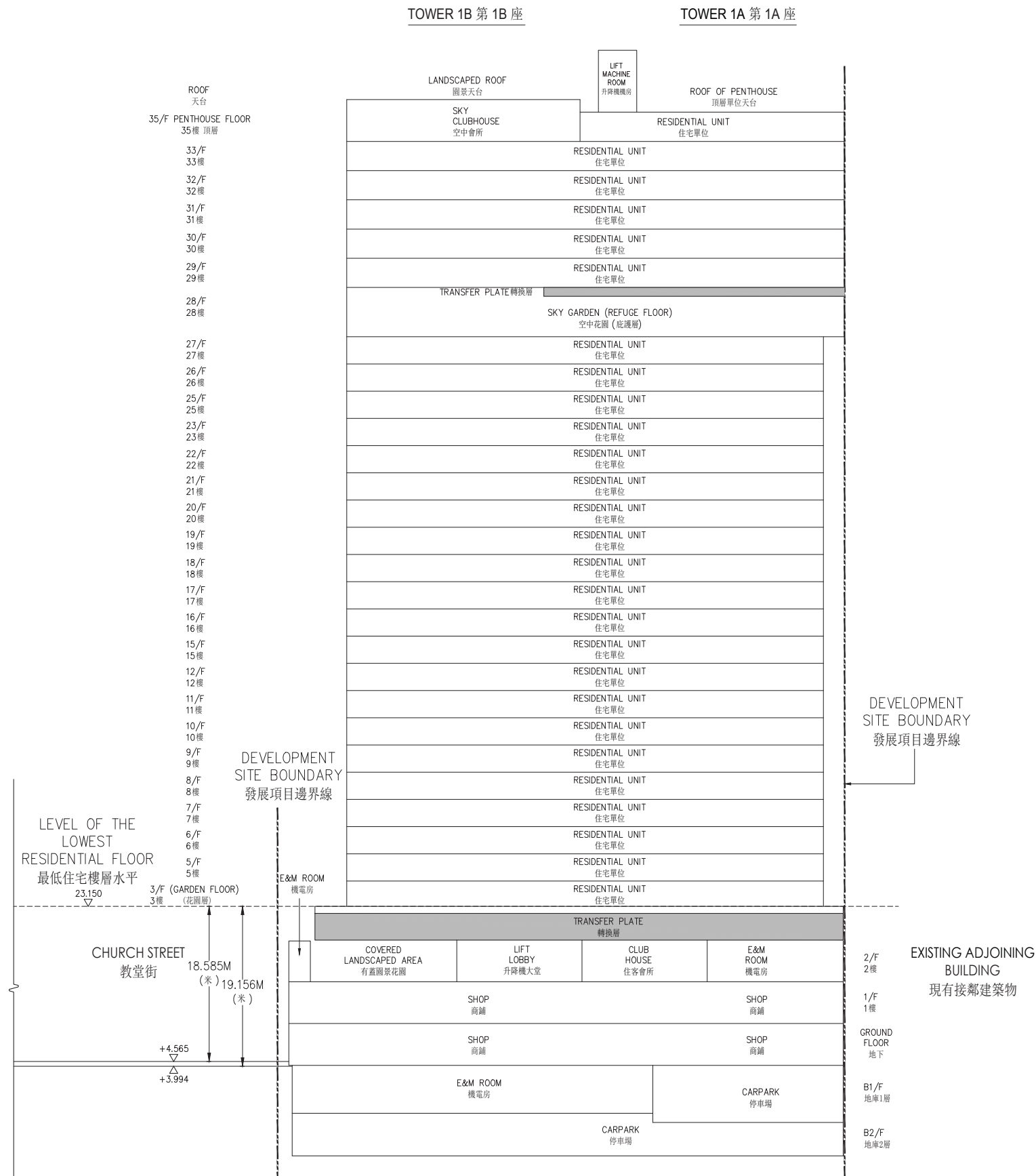

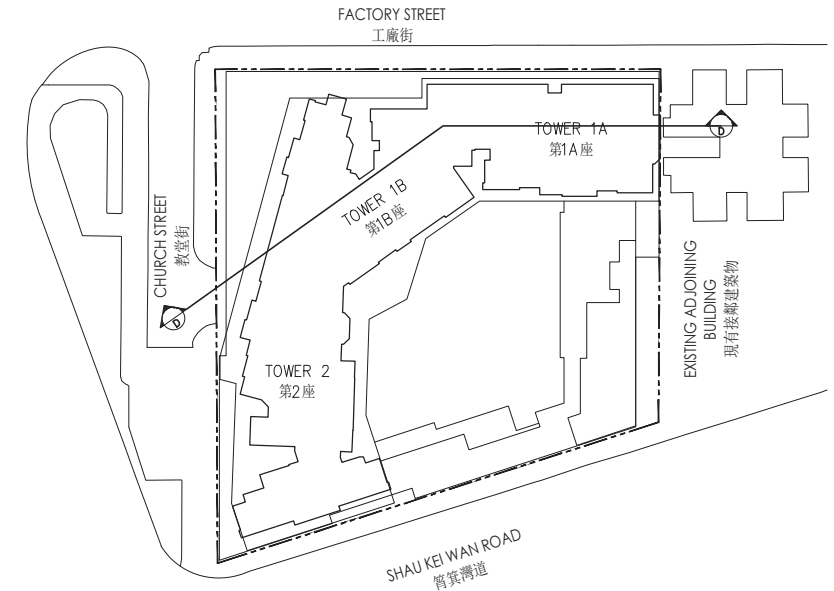

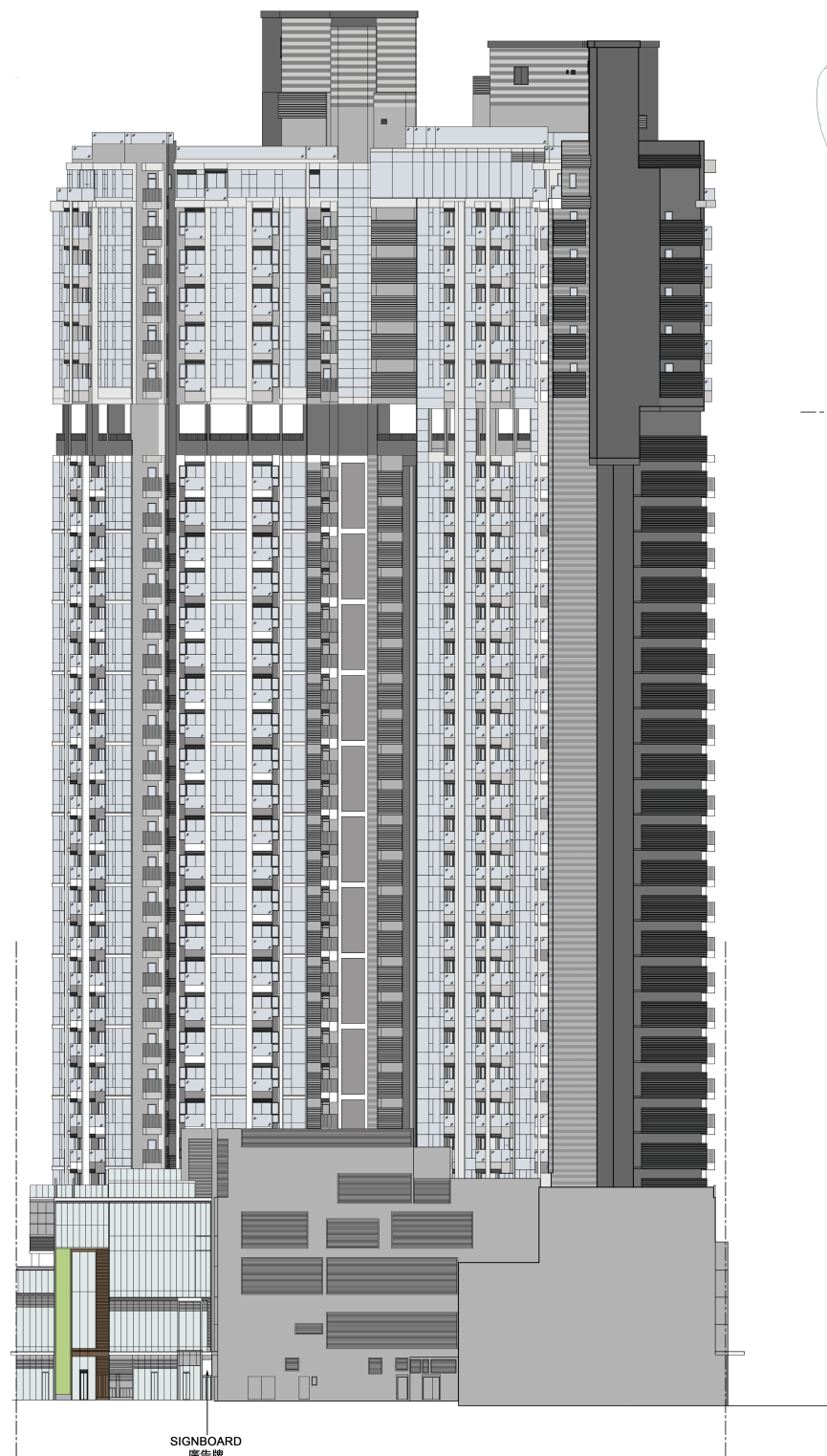

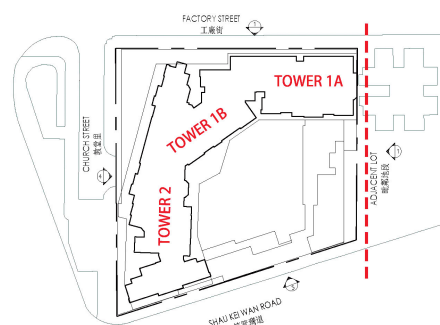

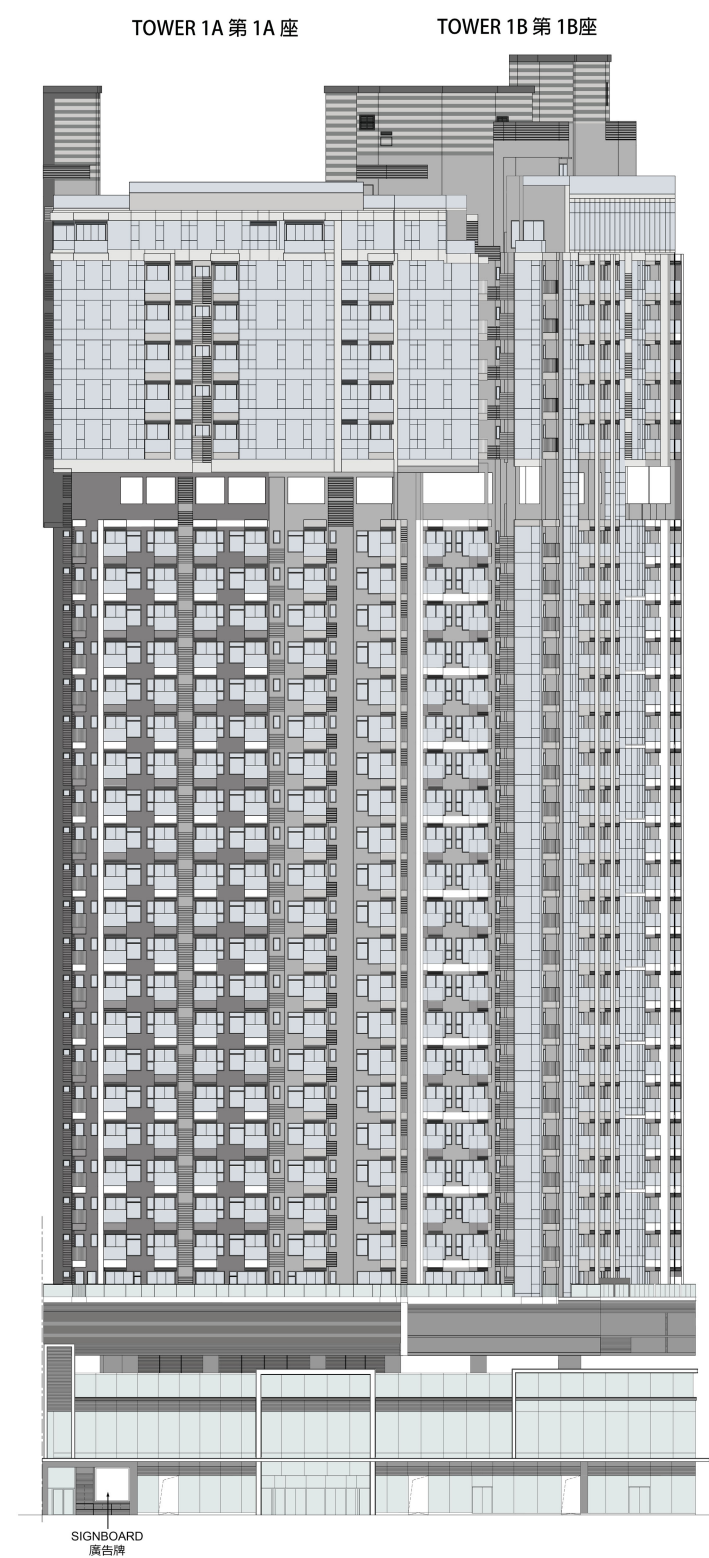
